I-CARE-SMART partners collect information that is connected to individual persons – such as name, postal address, e-mail address and profession- that users of the SilverStar Community knowingly and voluntarily provide by completing one of the forms on the website. The processing of your personal data is done in compliance with the applicable legislation on data protection and in particular Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and in the conditions set forth in this privacy policy.

USE OF YOUR PERSONAL DATA.

COMMUNICATION OF YOUR PERSONAL DATA.

If you do provide personal data through one of our forms, such data may be shared with logistics partners and providers, who are contractually permitted to use such data solely in connection with organizing and conducting the organism's activities.

The organism will not sell, share or rent your Personal Information to others in ways different from what is disclosed in this Privacy Policy. The organism does not attempt to identify or share user information with any parties outside of the association, except as required by law or as required in the course of officially authorized law enforcement investigations, or in order to protect our rights.

ELECTRONIC MAIL.

When you send us personal data via e-mail (that is, in a message containing a question or comment, or by filling out a form that e-mails us this information), we use it to respond to your requests. We may forward your e-mail to other employees of the organism who are better able to answer your questions. We do not retain or distribute lists of e-mail addresses to any parties outside of the organism. In no event, do we distribute lists of e-mail addresses to any outside parties. Information collected via e-mail will be retained at our discretion in a directly readable form as long as necessary to complete our response.

YOUR RIGHTS.

In accordance with articles 39 and 40 of the Act n°78-17 of January 6, 1978, you can access, modify, delete all your Personal Data published on this platform and object to the processing of your Personal Data for legitimate reasons.
